TAXIWAY ROMEO SEGMENT CLOSURE

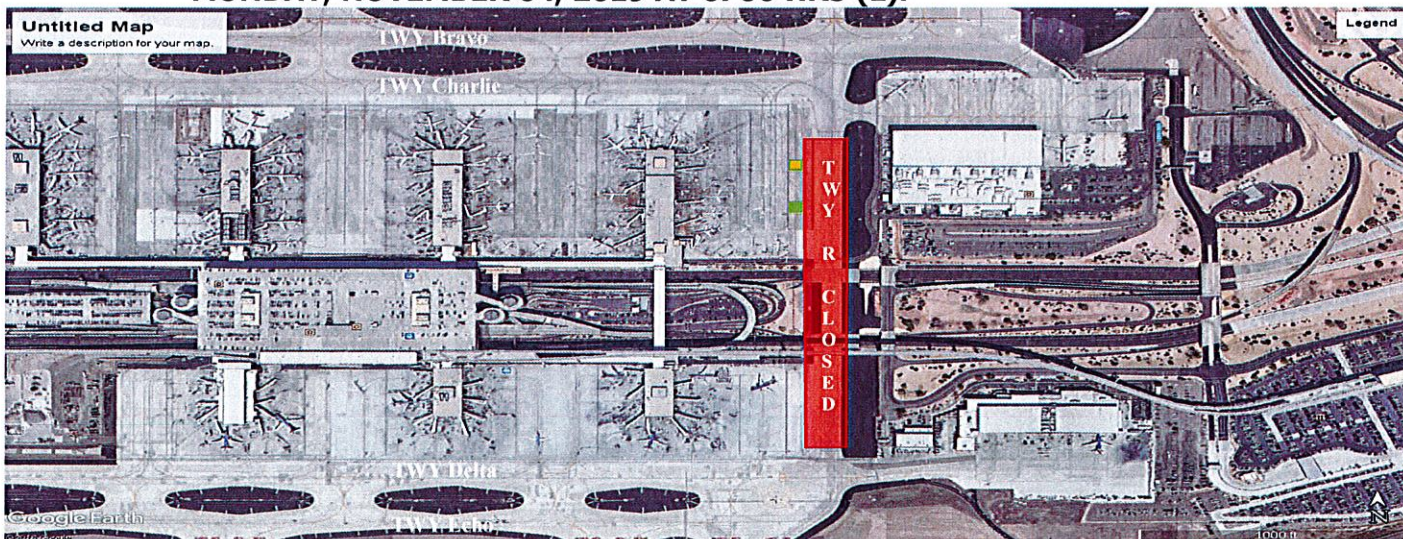
TAXIWAY ROMEO SEGMENT CLOSED BETWEEN THE WEST ENTRANCE TO THE AMERICAN AIRLINES' HANGER AND TAXIWAY DELTA FOR TAXIWAY RECONSTRUCTION.

AMERICAN AIRLINES' HANGER WEST ENTRANCE WILL BE OPEN.

TRANSITION POINTS ORANGE AND GREEN WILL BE CLOSED.

ALL AIRCRAFT LARGER THAN A B757-300W OR WINGSPAN OF 135 FEET OR LARGER PUSHING OFF OF GATE B25 WILL PUSH TAIL WEST ON TAXIWAY CHARLIE. AIRLINES WILL CALL CITY OF PHOENIX AIRPORT OPERATIONS (602 273 2008) 15-MINUTES PRIOR TO PUSH SO PUSH CAN BE MONITORED.
